

# PRIVACY POLICY

This policy covers DigitalVPO use of personal information that DigitalVPO collects when you use <https://digitalvpo.com>

By entering your details in the fields requested, you enable DigitalVPO to provide you with the services you select. Whenever you provide such personal information, we will treat that information in accordance with this policy. When using your personal information DigitalVPO will act in accordance with current legislation and aim to meet current Internet best practice.

## Use and storage of your personal information
